# Changes to Mason Stevens Super administration fees

Mason Stevens Super (**Fund**) is issued by Diversa Trustees Limited (**Trustee**) ABN 49 006 421 638 AFSL 235153 RSE Licence No. L0000635.

Effective **14 February 2025,** new administration fees will apply to your Mason Stevens Super account.

## What is the reason for the change?

Recent guidance from the Australian Taxation Office (**ATO**) with respect to the treatment of reduced input tax credits (**RITC**) that can be claimed by platform super funds has meant the Trustee has had to reassess its ability to meet significant increases in operational costs incurred by the Fund and its ability to continue meeting regulatory obligations in providing members with the best outcomes.

## What are the new fees for Mason Stevens Super from 14 February 2025?

The current fees outlined in the Product Disclosure Statement (**PDS**) and the new PDS fees from 14 February 2025 are outlined below in Table 1. All fees are inclusive of Goods and Services Tax (**GST**) and net the effect of any reduced input tax credits.
