References to your adviser include when the act or omission is by the adviser's delegate.

- » You release, discharge and indemnify each of the Trustee, the Administrator and Mason Stevens and each other persons acting on behalf of them respectively (and all of their respective successors and assignees) from and against all losses, actions, liabilities, claims, demands and proceedings arising from your appointment of an adviser from time to time, and all acts, matters and things done or purported to be done by the adviser even if not actually authorised by you or you have not notified Mason Stevens or the Administrator of any limitation or revocation of their authority to act on your behalf.
- » If your new adviser is not registered, fails to register or does not qualify to be registered with Mason Stevens platform and another adviser is not appointed within a reasonable time-frame, we may, at our discretion close your account.
- » Receipt of this form will be taken as authority to remove your previous adviser from your account indicated on this form. Fees will no longer be payable to your previous adviser.
